Ron Miller and David Youngblut have been working on prospective details for the pavilion project enabled by the Geyer donation. The projected cost of what they have developed is currently estimated at \$172,000, but does not include everything that would be needed. Youngblut stressed that this is a starting point. As the projection is higher than the anticipated \$120,000 donation, scaling back or additional fundraising could be required. Concerns, such as if a second facility of this type would keep casual park users from accessing the rest of the park and how to make sure this is the best use of the donation were discussed. Priebe said much more information would be provided before final decisions were asked for from the Board.
