i. The Warren County Conservation Board held its regular monthly meeting on Wednesday, February 10, 2021. The meeting was held electronically. Meeting called to order by President Kickbush at 6:00 p.m.

ii. Reading of Minutes.

Minutes of the January 2021 Warren County Conservation Board meetings were reviewed. Ace Hendricks moved to approve minutes as written. Motion seconded by Joe Schettler. Motion carried by unanimous vote.

- iv. Business Agenda:
  - a. Old Business:
    - 1. Friends of Warren County Conservation report:

The FWCC are planning an in person & virtual Osprey 5K Trail Run. Friends voted to keep the same officers.

2. Middleswart Lodge:

The Middleswart donation amount remaining is \$11,609. February lodge expenses totaled \$2,743.42. The following still need to be completed in the lodge: additional tables/chairs, concrete, restroom partitions, kitchen backsplash, and potentially a sprinkler system. Joe Schettler reported the findings from the fire inspector and options for opening the building without a sprinkler system and still meeting code. The lodge could be opened with no stove or anything that would cause a grease fire, no sprinkler system, and no alcohol with a letter explaining the policy prior to reservations. Discussion followed in regards to Annett Nature Center rentals and the goals of the new lodge. Joe Schettler moved to adopt a policy at this

time with no alcohol allowed at the lodge or outdoor space and to include the kitchen modifications required to meet code. Motion seconded by Ron Miller Motion carried by unanimous vote.

3. Snyder & Associates Great Western Trail-Rich Voelker

Rich presented the draft, scope, and fee proposal for the Great Western & Summerset Trails. Part of the proposal includes assistance with 3 grants state, federal, or private. The assistance includes them writing & submitting the grants. Grants will likely need to be submitted multiple times before awarded. The first grant will be due July 1. The evaluation of the trails can begin as soon as the trail is clear of snow. WCCB will need to provide background and location of culverts to Snyder. The first payment will be in April and billing occurs monthly. Ron Miller moved to accept the Great Western Trail and Summerset Proposal with Snyder & Associates. Motion seconded by Joe Schettler Motion carried by unanimous vote.

## b. New Business:

1. Carlisle Connection 28 E Agreement

The board reviewed the Carlisle 28 E Agreement for the Carlisle Connection Trail. WCCB would maintain about ¼ mile of the trail. Joe Schettler moved to approve the Carlisle Connection 28 E Agreement Motion seconded Ace Hendricks Motion carried by unanimous vote.

2. Co-Director & Office Manager Positions

The co-director and office manager positions were discussed. Discussion included: positions, options of relisting the director's position, command chart, bylaws update process, attendance at workshops, developing partnerships, and organizational change.
