 - 1. There was a small sink hole on the GWT trail. Upon further inspection it turned out to be larger than appeared. G and G landscaping was hired to help repair the culvert and trail.
 - iii. Middleswart Lodge
 - 1. Mark Wilson lowered the water lines between the restrooms to help prevent them freezing in the winter.
 - 2. In the future we may need to look at heating for the building. The mini splits should not be used as the primary source of heating. When it gets really cold they are not able to keep up.
 - 3. Staff will be redoing the sidewalk on the East side of the building. This will help with water runoff. Currently it pools by the kitchen door.

 - He is working on eliminating lines we no longer use, adding \$15,000.00 for professional fees, suggested \$50,000.00 in a reserve for Great Western Trail, \$3,000.00 for Grant Nature Land's campground, and \$60,000.00 for a new truck.
