    - i. Staff have been working to repair the cracks that run with the trail. They tested Cold Patch to see if it would hold better than straight tar. Staff noticed quite a difference using the cold patch.

    - Kelsey participated in the STEAM Day at Wilder Elementary. She saw over 500 kids in one day.

    - i. Tyler purchased fireproof pants for the entire staff. They will use these during burn season.

 Philanthropic Grant. She is going to use the funds to purchase a manual All-Terrain Wheelchair that will allow school aged children all the way up to
 adults to use our trails at the Annett Nature Center. She is going to ask
 FWCC to be her financial sponsor for this grant.
